Some of those agencies/businesses/professions are the following (not all inclusive list): Department of Professional Regulation (DBPR) regulates contractors, alcohol sales, many professionals, restaurants, and many more- see their site for all regulated businesses; Pharmacists are regulated by the Board of Pharmacy; Assisted living facilities, nursing homes, residential centers, etc. are regulated by the Agency for Health Care Administration; Pest Control, Dance studios, Health studios, Gyms, Sellers of travel, Telemarketing services, Motor vehicle repair shops, CDB sales, Packaged Food sales, Pawn shops and many more are regulated by the Department of Agriculture and Consumer Services (DACS) - see their site for all regulated businesses; Secondhand Dealers are regulated by the Department of Revenue; Daycares and Group Foster Homes are regulated by the Florida Department of Children and Families; Motor vehicle sales, salvage & vehicle auctions are regulated by the DMV; Flagler County Department of Health regulates body piercing, tattoo studios, mobile home parks, campgrounds; Department of Financial Services regulated insurance sales.
