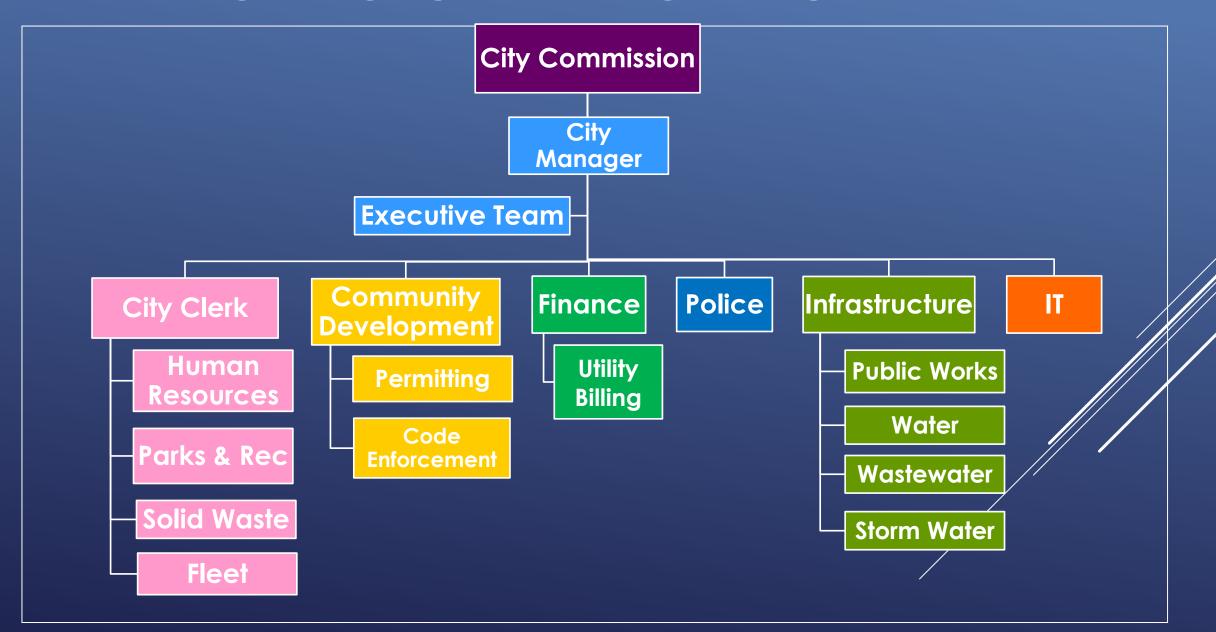

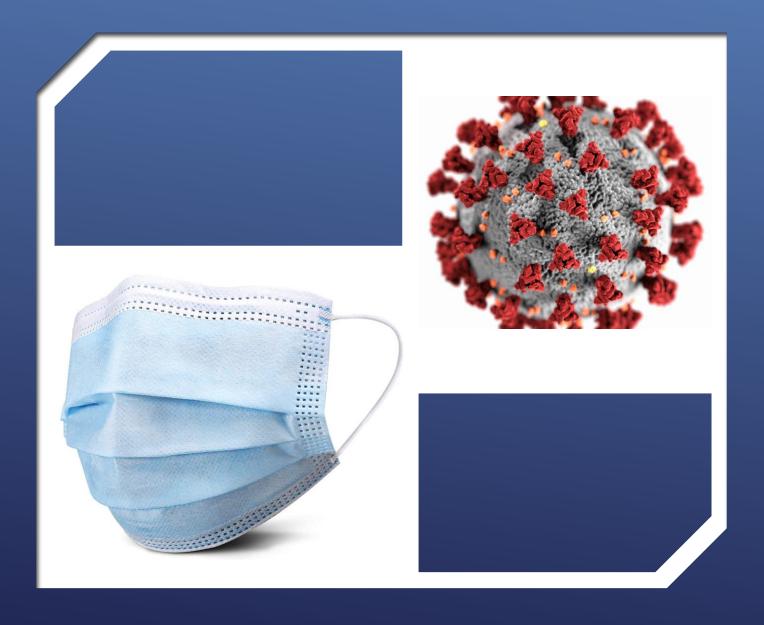

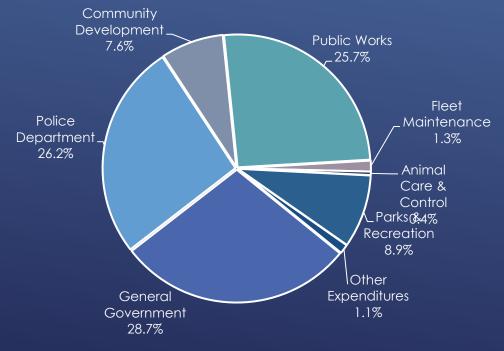

- Documentation of and destruction of 33.5 cubic feet of City records in accordance with the State Records Management Standards
- 391.75 Invoiced Hours spent fulfilling records requests (this does not include the requests fulfilled in 30 minutes or less)



The One-person Department responsible for all things technological, operating systems, computer (hardware and software), and office equipment related

- Several projects with Tyler Technologies regarding making City operations easier to conduct as staff continues to be located across the City and at remote sites
  - Migrated Financial Systems database to a Tyler Technologies datacenter
  - Accounts Payable Automation
  - ► Testing web interface modules for Community Development, Code Enforcement and Business Tax Receipts
  - Upgrade of the document management software in Tyler Technologies software
- ▶ Set up of all alternate workspaces and offices as operations moved out of 201 West Moody
  - All technology and office equipment, including wiring for the areas
- ► Migration to a new City phone system that allows staff to use computers and work cell phones rather than needing desk phones



- ▶ Relocation of City Network Servers to the Water Treatment Plant
- Assisting with acquiring an Automatic Vehicle Location (AVL) system; GPS for majority of the City fleet which can also be used for maintenance tracking
  - Within this project also purchased dashcams for the solid waste trucks which assist with responding to issues about service





- Relocation of employees and customer service operations out of 201 W. Moody Blvd.
- ▶ RFP for sale of 201 W. Moody issued and buyer ready for contract
- Site selection, due diligence and conceptual planning for new City Administration/Police Headquarters Building
- Continued to work with Utilities to develop financial plans for the Master
   Plan and provide documentation to apply for funding opportunities
  - ▶ \$1 million loan/grant for WWTP design (80% loan forgiveness grant/20% loan)
- Prior year was closed out and ready for audit in December
- Managed revenue and expenses associated with COVID and the CARES Act
  - ► Received the 1<sup>st</sup> half of Bunnell's allocation ARPA funding \$737k to assist with WWTP project
- ▶ Maintained increase in bank interest (from 0.05% to 0.25%)
- ▶ New Impact Fee collections began in November 2020

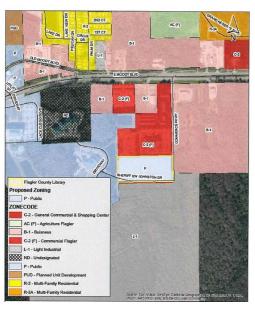

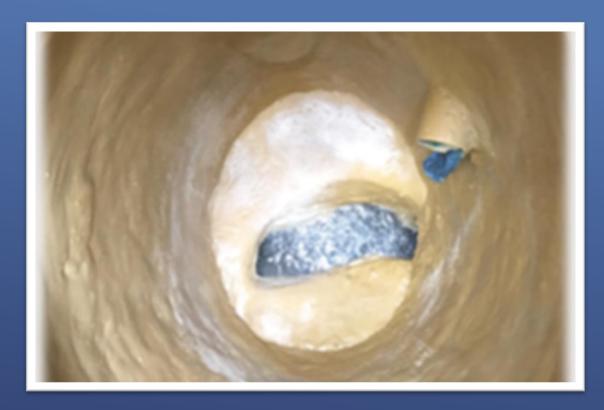

# HMGP MOBILE GENERATORS – GRANT (NEW EQUIPMENT)



- Created a Traffic Stop Data Collection Report (TSDR) for recording and collection of data related to traffic stops conducted by BPD officers
- Hired six sworn officers to fill vacant BPD officer positions
  - BPD is more culturally diversified now, then ever
- Created two public safety officers to provide emergency services and administrative support
- Completed a full assessment of the department to identify areas of need and improvement
  - Purchased much need supplies, such as, but not limited to ammunition, cameras, digital recorders, and tactical firearms
- Disposed of numerous outdated items from BPD's evidence and property room
- Every BPD officer is now utilizing an external load bearing vest to better distribute the weight of departmental issued equipment to help reduce the strain on their hips and lower back
- Started work on creating a new BPD shoulder patch to align with the City of Bunnell's logo

**EFFECTIVE: July 1, 2021** 

With changing standards in what sites are capable of recycling at this time, to be better fiscally responsible to its citizens, the City of Bunnell has to make changes to it's residential recycling program. Below are the items that should be placed in the YELLOW carts.



**CLEAN** Cardboard, Shipping Boxes and pantry food type storage boxes

MUST BE FREE FROM FOOD
RESIDUE, PLASTIC BAGS food came in AND
PLASTIC WINDOWS like on pasta boxes

#### ABSOLUTELY NO:

- Pizza boxes
- Newspaper, Magazines & Junk Mail
  - · Paper and tissue paper

Aluminum (free from food residue) such as:

- Cans
- Bottles
- Pans
- · Other aluminum Products

MUST BE FREE FROM FOOD RESIDUE

#### **Grand Reserve:**

#### YARD WASTE RULES:

- Compact PILES no larger than 6'x6'x6'
- No string, plastic ties, hoses, bags or other debris should be included with vard waste
- ONLY 6 yard per month is FREE
- If a contractor is hired for tree removal and leaves the debris at the right of way, the City is obligated to remove the hazard from the right of way and charge for the pick-up

#### CART PLACEMENT: USE CITY ISSUED CARTS ONLY

- · Face lid opening of cart toward the street (handles & wheels facing house)
- Place front of cart within 3 feet of street edge allowing 2 feet of clearance on each side of cart
- Do NOT fill carts with construction debris, dirt or yard waste
- <u>Do NOT</u> place carts near parked cars, fences, mailboxes, trees, other carts, or any other obstruction that could interfere with the truck picking up your cart.
- DO place them within 3 feet of the paved street.
- It is recommended to place carts out the night before. The driver will not turn around if your cart
  is not out when the truck has passed your house.
- Drivers do not exit the truck to handle debris left on the ground or piled on top of cart.

For bulk pick-ups, please call BEFORE the pick-up day to ensure your work order will be completed.

- There are NO charges to pick up residential furniture such as mattresses, couches, rugs, etc.
- There ARE charges for tires
- There ARE charges for construction materials—doors, wood, cabinets, pallets, drywall, tile, pavers, etc
- There ARE charges for appliances and fixtures- TVs, toilets, washer/dryer, hot water heater, fridges, etc.
- There ARE charges for household clean out/move out piles

In October, the City was informed it ranked #49 with a "high" probability of getting awarded the requested funding for FY 22/23

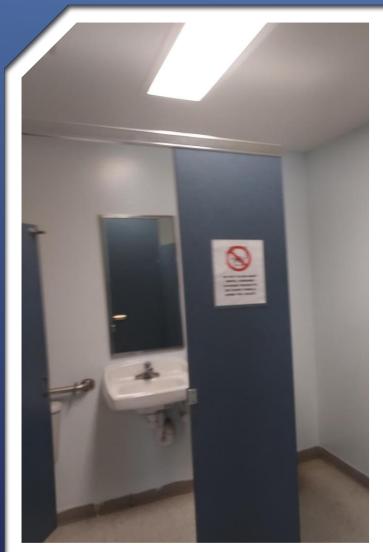
# FUNDING SOUGHT FOR HISTORIC COQUINA CITY HALL

### 2022- WHAT IS PLANNED

- ► The Commission Advance was held January 28, 2022; during this session many areas and topics were discussed to plan for the upcoming year and for Budget season Fiscal Year 2022/2023
- ► The City continues to seek funding from all possible sources for projects, this includes grants and loans and any combination of grant/loan/City match that is available
- Planning for the new Administration Complex and Police Department is on-going
- ► The City is working on the required amendment to its Comprehensive Plan adopted in 2011
- ► The City is planning to correct zoning inconsistencies for those parcels that still carry Flagler County zoning designations; this will change the zoning on over 800 parcels
- ▶ The 2022 Election was held March 8, 2022
- ▶ The Charter Review Committee will be convened this year for any possible Charter Amendments to be voted on in 2023
