
Sent out an email to all users about some Covid-19 scams that are already showing up, and urging our folks not to fall for the trap. Also created an additional training campaign on working from home.





Business Tax Receipt Renewals for FY 19/20

Since 2013, the City has partnered with the Flagler County Tax Collector for all local business tax receipt renewals. As of March 30, 2020 there were a number of businesses which had not renewed their FY 19/20 local business tax receipt—121 businesses within the City. With the current penalties due, this is an estimated \$19,000.00 still due to the City. Florida Statute Chapter 205 does not allow Code Enforcement action to be started until 150 days from notice (done in July 2019) has passed. The Clerk's Office referred all the businesses in the City limits to Code Enforcement for processing.

West Side Sewer and Drainage Rehabilitation:

2020 SJRWMD REDI Sewer Slip Lining Rehab Project:

\$ 6,735

\$500,000

Project is slip lining 2.85 miles of cured-in-place pipe (CIPP) within existing vitrified clay pipe (VCP) in the City's wastewater collection system. Contractor piggyback agreement approved by Commission at the March 23, 2020 meeting. Construction scheduled to begin in April.

West Side Storm Water Improvements Phase II:

\$ 2,433

Phase II would install corrugated pipe and filter media in the ditches on Deen Rd, Franz, and a portion of 4th St. This system will increase storage capacity as well as clean storm water before leaving our MS4 system and entering receiving state water bodies. Grant application submitted, awaiting SJRWMD decision. If selected by SJRWMD, construction would begin early October 2020.

Community Development Block Grant (CDBG):

Application process in progress. CATF volunteer appointment approved by Commission at the March 23, 2020 meeting.

Hazard Mitigation Grant Program (HMGP):

Application submitted for five mobile lift station generators for city-wide lift station coverage during storm events.

Historical Preservation Grants Program:

Requested information from Parks & Rec: \$ would need to be budgeted next fiscal year to rehab the Coquina Building. Must have 25% match up front when application submitted (April 2021). Details from Parks & Rec regarding work to be done and estimated costs is pending.

Utility Master Plan & Retreat:

This project is to evaluate every aspect of the City's potable water, sanitary sewer, stormwater, and other systems and develop a master plan to accommodate future growth.

The Master Plan was accepted by the Board at the March 9, 2020 Commission Meeting.

WTP Well #7 Rehab:

\$ 9,975

Evaluate and rehabilitate Water Treatment Plant Well #7.

Evaluation conducted. FDEP Permit modification approved by Commission at the March 23, 2020 meeting.

Wastewater Treatment Plant Rehab / Expansion:

Infrastructure Hired 2 new trainees, Marcus Butts, and Daniel Rayl for the collections and distribution crews.

Capacities WTP/WWTP

Capacity for the WWTP in March 2020 was 66% with a total of 0.12" of rainfall. Total influent flow for the month was 12.350MG, with a Daily Average of 0.398MG

The WTP produced 8.767MG of drinking water, with a daily production average of 0.282MG in March 2020. With our WTP putting out 8.767MG and our WWTP receiving 12.350MG, we treated 3.583MG of storm/ground water. Higher flows are seen during the COVID-19 pandemic, as more residents are staying home all day.

Bunnell Represents at the Polar Plunge





Finance Department



BUDGET PERFORMANCE FISCAL YEAR 2019



March was the sixth month of Fiscal Year 2019/2020 so we are half way through. The approved 2019/2020 budget, including amendments, totals \$10,458,241 and includes all anticipated revenues and expenditures of the city from October 1, 2019 through September 30, 2020. The chart shows year to date revenues and expenditures by fund.

General Fund – The General Fund has total revenue of \$2,377,670 while expenditures currently total \$1,807,949.

CRA Fund – The balance in the CRA Fund is \$3,628. There are no revenues or expenditures anticipated in the fund for FY 2019/2020.

General Debt Service Fund – The General Debt Service Fund accounts for the debt service payments required for the Municipal Complex. Monthly, \$5,633 (equal to 1/12th of the debt service payments) is transferred from the General Fund to the Debt Service Fund and the payments are processed quarterly. The second quarterly payment was made in March.

Water/Sewer Fund – The Water and Sewer Fund has total revenue of \$1,907,313. The expenditures total \$1,660,100.

Solid Waste Fund – The Solid Waste Fund has revenues of \$390,793 and expenditures of \$339,863.
