





Capacities WTP/WWTP


- Capacity for the WWTP in May 2019 was 68% with a total of 9.31" of rainfall. Total influent flow for the month was 12.257MG.
- The WTP produced 8.494MG of drinking water, with a daily production average of 0.274MG in June 2019. With our WTP putting out 8.494MG and our WWTP receiving 12.257MG, we treated 3.763MG of storm/ground water. This is an increased amount due to increased rainfall, however it is a vast improvement over months of similar rainfalls. Slip lining is showing improvements in wet weather flows.

Projects

<u>Infrastructure: West Side Sewer and Drainage Rehabilitation:</u> Project Number 2018-01 - This project is to rehabilitate manholes, install a pipe liner, and provide storm water improvements by repairing, replacing and reshaping the swales in the western section of the City. Primarily along Deen Rd, and some of the side streets. The purpose of this project is to better storm water drainage in the area as well as mitigate storm water from getting into the wastewater collection system and overloading the wastewater plant during wet weather.

West side storm and sewer project construction/work has recommenced. Culverts have been installed at the last two residential drive ways (work from change order #3). Conflict manhole installation began June 15th. Three of the four conflict structures and associated pipe crossings are installed. Inclement weather and subcontractor's continuing inability to schedule crews have caused more delays. Remaining scope is to install last conflict structure, redress ditches, and hydro seed the ditches. We expect completion end of July.

This project is partially funded by a grant from the St. Johns River Water Management District (SJRWMD) Rural Economic Development Initiatives (REDI) Grant program. Additional funds are from the Wastewater Enterprise fund.



<u>Infrastructure: South Side Sewer and Drainage</u>

Project: Project Number 2017-03 - This project is to rehabilitate manholes, install a pipe liner, and increase the size of a force main in the southeastern area of the City. The purpose of this project is to mitigate storm water from getting into the wastewater collection system and overloading the wastewater plant during wet weather. This project is funded in part by a Community Development Block Grant from the Florida Department of Economic Opportunity. Remaining funds are from the Wastewater Enterprise Fund.

This project is approximately 40% complete. Clean out installations are complete per Pay Request #3. Lateral lining is scheduled to begin July 22nd. Infrastructure crews began the rehab of Lift Station #2. Plumbing is

completed, it is tied in, graded and leveled for concrete. We are requesting Commission approval at the July 22nd meeting for lining. Surveying for Western Hills lift station is complete. Force main installation to be scheduled.

<u>Infrastructure: Reclaim Waterline Extension Phase II</u>: The City was awarded \$493,176.41 grant from the SJRWMD REDI program to further extend a reclaim water line along East Moody Blvd to bring reuse irrigation water to more commercial customers in the area. This is in the design phase, expect to go out for bid mid-July.

Projects

<u>Utility Master Plan</u>: This project is to evaluate every aspect of the City's potable water, sanitary sewer, stormwater, and other systems and develop a master plan to accommodate future growth.

The City of Bunnell conducted a second town hall meeting on Tuesday, June 4th at the Coquina City Hall. The Utilities Master Plan team, comprised of Kimley-Horn, CPH, and Abelita LLC, presented information about the master plan, economic development funding strategies, and community engagement. Notices regarding the town hall meetings were disseminated via the city's website, Facebook page, handbills given out at the Bunnell Bonanza, email distribution, and word-of-mouth. The meeting had five attendees beyond those representing the city and project team. The attendees participated in the discussion by asking questions or making comments about what was presented and expressed appreciation to the city for providing early information.

The city's online survey, launched on April 5, 2019, closed on June 10th. The survey was available through a link on the city's website and Facebook page. Announcements about the survey were made at each of the town hall meetings, the community champions' meeting with the city manager, and periodic email reminders. A total of 95 people participated in the survey, with a 100% completion rate, representing the highest participation rate of prior survey results for Bunnell. All participants answered all six questions on the survey, and some provided additional responses to open-ended questions. Of the 95 participants, 52 provided recommendations to the city concerning its communications and engagement with the community. Additionally, 56 participants provided an email address to receive communications from the city, of which 14 were duplicates of those already in the city's database and 43 were new entries. Full details of the survey results are being provided by Abelita LLC to the city in the near future.

The WWTP Capacity Analysis Report was completed by Kimley Horn and submitted to the Florida Department of Environmental Protection. This report showed the WWTP is indeed at capacity and soon to exceed its permitted capacity. By submitting this report to FLDEP, the state is going to require action on WWTP improvements to take place quickly. We have decided to push the WWTP portion of the Master Plan to top priority.

Officer Hirschi responded as a backup officer for the Flagler Sheriff deputies who were conducting a traffic stop in the City of Bunnell. As one of the deputies was approaching the drivers side of the vehicle, Officer Hirschi cautiously approached the passenger side without the driver's knowledge. As the deputy instructed the driver to exit the vehicle, Officer Hirschi saw the driver reaching for a handgun he was sitting on. Without hesitation, Officer Hirschi immediately drew his firearm, simultaneously yelling "gun", alerting other deputies of the driver's initial actions, consequently changing the driver's mind. The driver was taken into custody without incident and the firearm was recovered.

Chief Tom Foster stated, "We are very proud of Officer Matt Hirschi and because of his immediate action, attentiveness and training, a deadly force encounter was avoided, and a follow law enforcement officer went home."



This program gets the Officers out of their vehicles and encourages the following:



BUDGET PERFORMANCE FISCAL YEAR 2019



June is the ninth month of the fiscal year which represents 75.00% of the fiscal year. The graph above reflects fiscal year to date revenues in the City's three major funds.

General Fund-Revenues are above anticipated levels by 1.01%. This surplus is primarily due to the timing of grant revenue being accrued which accounts for \$382,262 of annual revenue. Just over 98% of Ad Valorem tax revenue has been received by June. In addition, the sale of the surplus fire truck resulted unbudgeted \$31,475 of unbudgeted revenue. The anticipated new construction activity is now progressing as anticipated in the budget.

Water Sewer-Fund operating revenue are below anticipated levels by 14.8% year to date. This shortfall is due to the construction timing of several grant projects. Revenue of \$970,197, for these projects will not be received until construction activities occur. Please note below a corresponding decline in anticipated expenditures due to the timing of these projects. We anticipate annual budgeted revenue to be in line with projections by the end of the fiscal year.

Solid Waste-Solid Waste fund operating revenues are above year to date budget by 13.5%. This is due to the unbudgeted host fee revenue collected in the amount of \$30,292 and loan proceeds of \$278,000 (for the purchase of a new garbage truck).



BUDGET PERFORMANCE FISCAL YEAR 2019

The adjacent graph reflects fiscal year to date expenditures in the City's three major funds.

General Fund - Expenditures are lower than expected due by 10.71%, due to timing of capital projects and expense payments. The major partially completed project include is the Deen Road storm water improvements.



Water Sewer Fund - Expenditures are significantly lower than anticipated by 32.23% of the year to date budget. The timing of capital construction projects expenditures is the major contributing factor. The projects include the Deen road sewer improvements, Waste Water treatment plant improvements, and the CDBG Southside sewer improvements.

Solid Waste Fund - expenditures are 2.04% above anticipated year to date expenditures. The expenditures include the purchase of a new garbage truck for \$278,717. Other expenditures are below expected levels due to the delay in debt repayment because of the new bank loan for the garbage truck.
