WHEREAS, Sexual Assault Awareness Month calls attention to the fact that sexual assault violence is widespread and impacts every person in this community; and

WHEREAS, rape, sexual assault, and sexual harassment impact our community and statistics show that one in five women and one in 71 men will be raped at some point in their lives; that one in six boys and one in four girls will experience a sexual assault before age 18; youth ages 12-17 are 2.5 times as likely to be victims of rape or sexual assault and on campus one in five women and one in 16 men are sexually assaulted; and

WHEREAS, during 2021, Family Life Center, as the certified Rape Crisis Center in Flagler County, provided 500 hours of peer-crisis counseling for survivors, 1,608 supportive services and answered 67 sexual assault crisis hotline calls for survivors of sexual assault and their families living in Flagler County; and

WHEREAS, the "Building Safe Online Spaces Together" public awareness campaign (a program of National Sexual Violence Resource Center) is designed to continue the conversation about building online communities centered on respect, inclusion, and safety and the ways we can work together to end sexual harassment, assault, and abuse online and offline; and

WHEREAS, the City of Bunnell joins advocates and communities across the country because we are strongest when we raise our voices together to change the culture to prevent sexual violence. Prevention requires addressing the root causes and social norms that allow sexual violence to exist. April is Sexual Assault Awareness Month, and each day of the year is an opportunity to create change for the future.

WHEREAS, the Flagler County Advocate Alliance (comprised of Victim Advocates from Bunnell Police Department, Family Life Center, Flagler Beach Police Department, Flagler County Sheriff's Office and the Office of the State Attorney, Seventh Judicial Circuit, Flagler) is hereby dedicated to strengthening victims and survivors in the aftermath of crime, building resilience in our communities and our victim responders, and working for a better future for all victims and survivors.

**NOW, THEREFORE,** I, Catherine D. Robinson as Mayor of the City of Bunnell do hereby proclaim April 2022 as Sexual Assault Awareness Month in the City of Bunnell and encourage all citizens to support the "Building Safe Online Spaces Together" public awareness campaign.

- **City Attorney –** Stated he expected to collect the money the City authorized to be paid to the Flagler County Humane Society tonight as part of the Court findings for restitution in the Circuit Court case.
- City Manager Allowed Chief David Brannon to give a report during his segment. Chief Brannon first thanked everyone for the warm welcome he and his family received at his swearing in ceremony. He reported making assessments of equipment needs, training, vehicles and learning the City. "Operation New Day" conducted his first weekend here set a new tone for a more proactive law enforcement presence in Bunnell. The Police Department has finished most of the move to 1769 E Moody, Building 14. He reported an upcoming event with the 9463 Foundation which is a group of motorcycle riders from South Florida that do a "Ride to Remember." This ride will stop in Bunnell at the First Baptist Church of Bunnell in the fellowship hall on March 21st at 1PM. Sergeant Guida's family has been invited to attend. Vice Mayor offered to bring the tow trucks and fly the American Flags from the cranes for the event.

#### Mayor and City Commissioners

- Commissioner Gordon congratulated Commissioner Barnes and Schultz on the election. She recognized the City Manager, Chief and Infrastructure Director for the good jobs they have done.
- Commissioner Barnes thanked the citizens that voted. He appreciates
  their trust in him and he will do everything he can to serve the City well. He
  stated he looked forward to working with the Board the next three years.
- Vice Mayor Rogers congratulated Commissioner Barnes and Commissioner Schultz on the election. He reported the National Day of Prayer will be held on May 5<sup>th</sup> and will be sponsored by Calvary Christian

#### WITNESSETH

WHEREAS, the COUNTY is a municipal corporation of the State of Florida, having a responsibility to provide certain services to benefit the citizens of City of Bunnell; and

## Summary/Highlights:

The applicant is requesting an amendment to the official zoning map to change the zoning on a 15.2± acre property from Flagler County, "AC- Agriculture" to City of Bunnell, "AG&S, Agricultural & Silviculture".

The property is designated "Agricultural & Silviculture" on the City of Bunnell Future Land Use Map in the Comprehensive Plan.

The Planning, Zoning and Appeals Board heard this request at their February 1, 2021 Meeting. At that meeting, the PZA Board voted to recommend approval of the proposed ordinance.

This item was last heard at the March 14, 2022 City Commission Meeting. At this meeting, the City Commission voted to approved the proposed ordinance. In accordance with Florida Statute, this ordinance was advertised in the March 17, 2022 edition of the Palm Coast Observer.

#### **Background:**

The applicant, First Coast Roll-Offs, LLC, owns a 15.2± acre property identified as Parcel ID's: 01-12-28-0000-01010-0011. The applicant plans to construct a wood recycling center on this site. These facility are regulated as a "Solid Waste Organics Recycling Facility" by the Florida Department of Environmental Protection. The applicant will be making a separate Special

Exception application for this proposed use.

The property is currently zoned Flagler County "AC-Agriculture". Although annexed into the City, the property did not receive a City of Bunnell zoning classification. The Flagler County "AC Agriculture" has a minimum lot size of five (5) acres.

The proposed zoning classification is City of Bunnell "AG&S, Agriculture & Silviculture". The intent of the "AG&S zoning classification is to "permit a range of agricultural and/or silvicultural use and to accommodate very low density residential development at a concentration of one dwelling unit per five acres".

The proposed ""AG&S, Agriculture & Silviculture" zoning is consistent with the Future Land Use Map and the existing pattern of surrounding development.

AGRICULTURE" TO CITY OF BUNNELL, "AG&S, AGRICULTURAL & SILVICULTURE"; PROVIDING FOR THE TAKING OF IMPLEMENTING ADMINISTRATIVE ACTIONS; PROVIDING FOR THE ADOPTION OF **REFERENCE: MAPS** BY **REPEALING** ALL CONFLICTING ORDINANCES: PROVIDING FOR SEVERABILITY: PROVIDING FOR NON-CODIFICATION AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS,** First Coast Roll-Offs, LLC, the owner of certain real property, which land totals approximately 15.2± acres in size located on the north side of State Highway 100 approximately two-thirds of a mile west of Water Oak Road within the Bunnell city limits and is assigned Tax Parcel Identification Number 01-12-28-0000-01010-0011, by the Property Appraiser of Flagler County; and

**WHEREAS,** First Coast Roll Offs, LLC has applied to the City of Bunnell pursuant to the controlling provisions of State law and the *Code of Ordinances of the City of Bunnell*, to have the subject property rezoned to the City of Bunnell "AG&S, Agricultural & Silviculture" zoning classifications from the existing Flagler County, "AC, Agriculture" zoning classification; and

**WHEREAS**, the City's Community Department has conducted a thorough review and analysis of the demands upon public facilities and general planning and land development issues should the subject rezoning application be approved and has otherwise reviewed and evaluated the application to determine whether is comports with sound and generally accepted land use planning practices and principles as well as whether the application is consistent with the goals, objectives and policies set forth in the City's *Comprehensive Plan*: and

**WHEREAS,** on February 1, 2022 the Planning, Zoning and Appeals Board of the City of Bunnell reviewed this request and recommended approval of the proposed ordinance to the City Commission; and

**WHEREAS,** professional City planning staff, the City's Planning, Zoning and Appeals Board and the City Commission have determined that the proposed rezoning of the subject property as set forth in this Ordinance is consistent with the *Comprehensive Plan of the City of Bunnell*, the land development regulations of the City of Bunnell, and the controlling provisions of State law; and

**WHEREAS**, the City Commission of the City of Bunnell, Florida has taken, as implemented by City staff, all actions relating to the rezoning action set forth herein in accordance with the requirements and procedures mandated by State law.

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF BUNNELL, FLORIDA:

## Section 1. Legislative Findings and Intent.

- (a) The City Commission of the City of Bunnell hereby adopts and incorporates into this Ordinance the City staff report and City Commission agenda memorandum relating to the application relating to the proposed rezoning of the subject property as well as the recitals (whereas clauses) to this Ordinance.
- (b) The subject property, which is approximately 15.2± acres in size, is located on the north side of State Highway 100 approximately two-thirds of a mile west of Water Oak Road in the City of Bunnell.
- (c) The City of Bunnell has complied with all requirements and procedures of Florida law in processing and advertising this Ordinance.

### Section 2. Rezoning of Real Property/Implementing Actions.





PUBLIC BUSINESS COMMERCIAL DEVELOPMENT AND CAPITAL IMPROVEMENTS

#### 288.075 Confidentiality of records.-

- (1) DEFINITIONS.—As used in this section, the term:
- (a) "Economic development agency" means:
- 1. The Department of Economic Opportunity;
- 2. Any industrial development authority created in accordance with part III of chapter 159 or by special law;
- 3. Space Florida created in part II of chapter 331;
- 4. The public economic development agency of a county or municipality or, if the county or municipality does not have a public economic development agency, the county or municipal officers or employees assigned the duty to promote the general business interests or industrial interests of that county or municipality or the responsibilities related thereto;
  - 5. Any research and development authority created in accordance with part V of chapter 159; or
- 6. Any private agency, person, partnership, corporation, or business entity when authorized by the state, a municipality, or a county to promote the general business interests or industrial interests of the state or that municipality or county.
- (b) "Proprietary confidential business information" means information that is owned or controlled by the corporation, partnership, or person requesting confidentiality under this section; that is intended to be and is treated by the corporation, partnership, or person as private in that the disclosure of the information would cause harm to the business operations of the corporation, partnership, or person; that has not been disclosed unless disclosed pursuant to a statutory provision, an order of a court or administrative body, or a private agreement providing that the information may be released to the public; and that is information concerning:
  - Business plans.
  - 2. Internal auditing controls and reports of internal auditors.
  - 3. Reports of external auditors for privately held companies.
  - (c) "Trade secret" has the same meaning as in s. 688.002.
  - (2) PLANS, INTENTIONS, AND INTERESTS.—
- (a)1. If a private corporation, partnership, or person requests in writing before an economic incentive agreement is signed that an economic development agency maintain the confidentiality of information concerning plans, intentions, or interests of such private corporation, partnership, or person to locate, relocate, or expand any of its business activities in this state, the information is confidential and exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution for 12 months after the date an economic development agency receives a request for confidentiality or until the information is otherwise disclosed, whichever occurs first.
- 2. An economic development agency may extend the period of confidentiality specified in subparagraph 1. for up to an additional 12 months upon written request from the private corporation, partnership, or person who originally requested confidentiality under this section and upon a finding by the economic development agency that such private corporation, partnership, or person is still actively considering locating, relocating, or expanding its business activities in this state. Such a request for an extension in the period of confidentiality must be received prior to the expiration of any confidentiality originally provided under subparagraph 1.

If a final project order for a signed economic development agreement is issued, then the information will remain confidential and exempt for 180 days after the final project order is issued, until a date specified in the final project order, or until the information is otherwise disclosed, whichever occurs first. However, such period of confidentiality may not extend beyond the period of confidentiality established in subparagraph 1. or subparagraph 2.

- (b) A public officer or employee may not enter into a binding agreement with any corporation, partnership, or person who has requested confidentiality of information under this subsection until 90 days after the information is made public unless:
  - 1. The public officer or employee is acting in an official capacity;
  - 2. The agreement does not accrue to the personal benefit of such public officer or employee; and
- 3. In the professional judgment of the officer or employee, the agreement is necessary to effectuate an economic development project.
- (3) TRADE SECRETS.—Trade secrets held by an economic development agency are confidential and exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution.
- (4) PROPRIETARY CONFIDENTIAL BUSINESS INFORMATION.—Proprietary confidential business information held by an economic development agency is confidential and exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution, until such information is otherwise publicly available or is no longer treated by the proprietor as proprietary confidential business information.
- (5) IDENTIFICATION, ACCOUNT, AND REGISTRATION NUMBERS.—A federal employer identification number, reemployment assistance account number, or Florida sales tax registration number held by an economic development agency is confidential and exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution.
  - (6) ECONOMIC INCENTIVE PROGRAMS.—
- (a) The following information held by an economic development agency pursuant to the administration of an economic incentive program for qualified businesses is confidential and exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution for a period not to exceed the duration of the incentive agreement, including an agreement authorizing a tax refund or tax credit, or upon termination of the incentive agreement:
- 1. The percentage of the business's sales occurring outside this state and, for businesses applying under s. 288.1045, the percentage of the business's gross receipts derived from Department of Defense contracts during the 5 years immediately preceding the date the business's application is submitted.
- 2. An individual employee's personal identifying information that is held as evidence of the achievement or nonachievement of the wage requirements of the tax refund, tax credit, or incentive agreement programs or of the job creation requirements of such programs.
  - 3. The amount of:
  - a. Taxes on sales, use, and other transactions paid pursuant to chapter 212;
  - b. Corporate income taxes paid pursuant to chapter 220;
  - c. Intangible personal property taxes paid pursuant to chapter 199;
  - Insurance premium taxes paid pursuant to chapter 624;
  - e. Excise taxes paid on documents pursuant to chapter 201;
  - f. Ad valorem taxes paid, as defined in s. 220.03(1); or
  - State communications services taxes paid pursuant to chapter 202.

However, an economic development agency may disclose in the annual incentives report required under s. <u>288.907</u> the aggregate amount of each tax identified in this subparagraph and paid by all businesses participating in each economic incentive program.

- (b)1. The following information held by an economic development agency relating to a specific business participating in an economic incentive program is no longer confidential or exempt 180 days after a final project order for an economic incentive agreement is issued, until a date specified in the final project order, or if the information is otherwise disclosed, whichever occurs first:
  - The name of the qualified business.

- b. The total number of jobs the business committed to create or retain.
- The total number of jobs created or retained by the business.
- d. Notwithstanding s. 213.053(2), the amount of tax refunds, tax credits, or incentives awarded to, claimed by, or, if applicable, refunded to the state by the business.
  - e. The anticipated total annual wages of employees the business committed to hire or retain.
- 2. For a business applying for certification under s. 288.1045 which is based on obtaining a new Department of Defense contract, the total number of jobs expected and the amount of tax refunds claimed may not be released until the new Department of Defense contract is awarded.
- (7) PENALTIES.—Any person who is an employee of an economic development agency who violates the provisions of this section commits a misdemeanor of the second degree, punishable as provided in s. 775.082 or s. <u>775.083</u>.

Per the City Code of Ordinance, there is a limit on the total number of garage sale permits that can be issued to a property/address point in a calendar year.





## **Business Tax Receipts (BTRs)**


It is Business Tax Receipt (BTR) Renewal season. Since 2013, the City has had an Interlocal Agreement with the Flagler County Tax Collector Office for processing BTR renewals. The Flagler County Tax Collector Office sent out the FY 21/22 notices or e-mails in July.


Businesses need to pay their FY21/22 BTR fees through the Flagler County Tax Collector Office by September 30, 2021. Florida Statute and the City's Code of Ordinance require penalties be added to a BTR if not paid by **September 30th**. The required penalties are as follows: 10% October 1st; 15% November 1st; 20% December 1st; and 25% January 1st.

The City processed a check in the amount of \$5,092.13 for BTR renewals paid to the Tax Collector Office in January 2022.





# <u>Cart Placement Regulations and</u> Guidelines

- ⇒ Face lid opening of cart toward the street (handles & wheels facing house)
- ⇒ Place front of cart within 3 feet of street edge
- ⇒ Allow 2 feet of clearance on each side of all carts and ANY obstruction
- ⇒ Do NOT fill carts with construction debris, dirt or yard waste
- ⇒ It is recommended to place carts out the night before. The driver is not able to turn around if your cart is not out when the truck is on your street.
- ⇒ Do not place carts near parked cars, fences, mailboxes, trees, other carts, or any other obstruction that could interfere with the truck picking up your cart.

Failing to follow the guidelines may result in service interruption (i.e. the City won't be able to collect your solid waste that day)
