D. Public Comments:

Comments regarding items not on the agenda. Citizens are encouraged to speak; however, comments are limited to four (4) minutes.

Joe Roos – (Secret Trail) congratulated the new Sergeants. He stated his purpose was to bring awareness to the community in the Favoretta area. He stated a 20-acre piece of property was being presented for a zoning change to Industrial. He understood it was rescinded prior to the PZA meeting; however, he thinks it is a ploy. He asked the Commission to understand this is a residential neighborhood which needs to remain a peaceful and quiet neighborhood.

Jodi Roos – (Secret Trail) stated she had several questions: 1. Why weren't notices sent to Flagler County residents; 2. How does a person check on a business's liability Insurance; 3. How do the residents in the area can request water tests; 4. If an industrial use is added to the City, does the City add more staff; 5. She asked about the annexation process and benefits of annexing.

Rick Barton – (Secret Trail) stated his main concern is the man that owns the property has done nothing to clean up the area since the fires and stated this is a residential area that needs to stay residential.

Jennifer Fries – (Ormond Beach) stated she butts up to the property and wondered why Flagler County residents in the area only get to see the sign posted but not get a notification letter. She stated the City was sprawling into rural areas without having the proper manpower to manage areas under the City's jurisdiction. She reported Arrow Materials is still taking in materials and has not ceased operations. She requested a water test.

Joe Gallagher - (E Twin Lakes) stated he strongly opposes this property being rezoned; this area is residential and needs to stay residential. He stated he is concerned about the environment and their way of life in the country. He urged the Commission to listen to the residents in this area if this matter ever comes before the City.

David Wayne – (Country Road) stated the gentleman has multiple properties in the area and he believes this gentleman will try to get all of the properties zoned industrial. He stated Favoretta is a small community. He is concerned about heavy traffic, drainage issues, noise quality and air quality issues that industrial uses bring.

Patricia Delgadillo – (Anderson Street) stated she has neighbors on Anderson Street that have storage units and have large trucks that make noise 24/7; her other neighbor is a welder and auto repair with much noise and disruption to her property. She asked the City to look into this area and to so something about the disturbances going on in her neighborhood.

MUNICIPALITY/ TRANSPORTATION PLANNING ORGANIZATION FY 2023/2024 FUNDING AGREEMENT

THIS AGREEMENT, is made and entered into this _____ day of _____ 2023, by and between the CITY OF BUNNELL, a municipal corporation organized and existing under the laws of the State of Florida (hereinafter "CITY"), and the RIVER TO SEA TRANSPORTATION PLANNING ORGANIZATION (hereinafter "R2CTPO").

WITNESSETH

WHEREAS, the River to Sea Transportation Planning Organization (R2CTPO) is the duly designated and constituted body responsible for carrying out the urban transportation planning and programming process for Volusia County and portions of Flagler County inclusive of the cities of Flagler Beach, Beverly Beach, and portions of Palm Coast and Bunnell; and

WHEREAS, Florida Statutes 339.175; 23 U.S.C 134; and 49 U.S.C. 5303 require that the urbanized area, as a condition to the receipt of federal capital or operating assistance, have a continuing, cooperative, and comprehensive transportation planning process that results in plans and programs consistent with the comprehensively planned development of the urbanized area; and

WHEREAS, metropolitan planning organizations are the lead transportation planning agencies in urban areas throughout the United States; and

WHEREAS, the Fast Act provides metropolitan planning organizations with the authority and responsibility for transportation planning and funding; and

WHEREAS, the quality of life and economic vitality of our community depend on coordinating transportation issues and developing complementary plans and policies; and

WHEREAS, the R2CTPO has the lead role in formulating regional transportation plans and programs and coordinating transportation issues among local entities and the Florida Department of Transportation (FDOT); and

WHEREAS, the CITY desires to enter into this Agreement with the R2CTPO to provide it with funding to support the functions necessary to achieve the R2CTPO's desired role in planning the transportation system;

NOW, THEREFORE, for and in consideration of the mutual covenants and agreements contained herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the CITY and the R2CTPO agree as follows:

- 1. **RECITALS.** The CITY and the R2CTPO hereby declare that the recitals set forth above are true and correct and incorporated herein.
- 2. <u>FISCAL YEAR 2023/24 FUNDING</u>. The CITY agrees to allocate \$260.00 to the R2CTPO. Such funds shall be paid to the R2CTPO upon receipt of an invoice from the R2CTPO to the CITY. The payment shall be used for the R2CTPO fiscal year (FY) 2023/24 budget effective July 1, 2023. The funding provided to the R2CTPO by the CITY is equal to \$.10 per capita based on the 2017 planning area.
- 3. <u>EFFECTIVE DATE AND TERMS</u>. The effective date of this Agreement is upon execution. The terms of this Agreement shall commence on the effective date and terminate on June 30, 2024.
- 4. <u>INTERPRETATION</u>. The headings contained in this Agreement are for reference purposes only and will not in any way affect the meaning or interpretation of this Agreement.

5. MISCELLANEOUS

- a. This Agreement constitutes the entire Agreement between the parties with respect to the specific matters contained herein and supersedes all previous discussions, understandings and agreements, written or oral, between the parties hereto. Any amendments to or waivers of the provisions herein shall be made by the parties in writing. No other agreement, oral or otherwise, regarding the subject matter of this agreement shall be deemed to exist or to bind either party hereto.
- b. If any sentence, phrase, paragraph, provision or portion of this agreement is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed an independent provision and such holding shall not affect the validity of the remaining portions hereto.
- c. The parties hereby acknowledge that they have freely and voluntarily entered into this Agreement and that each party has been given the opportunity to receive the advice of independent legal counsel for all negotiations in connection with this Agreement.

6. **CONTROLLING LAWS**

- a. This Agreement and the provisions contained herein shall be construed, controlled and interpreted according to the laws of the State of Florida, and all duly adopted ordinances, regulations and policies of the CITY now in effect and those hereinafter adopted.
- b. The location for settlement of any and all lawsuits, claims, controversies or disputes, arising out of, or relating to, any part of this Agreement, or any breach thereof, shall be Volusia County, Florida.
- c. The parties to this Agreement agree to comply with all applicable federal, state and local laws, ordinances, rules and regulations pertaining to this Agreement.
- 7. <u>BINDING NATURE OF AGREEMENT</u>. This Agreement shall be binding only between the CITY and the R2CTPO, and inure to the benefit of the successors or assigns of the parties.
- 8. **NOTICES.** All notices, consents, approvals, waivers and deletions which any party shall be required or shall desire to make or give under this Agreement shall be in writing and shall be sufficient only when mailed by certified mail, first class postage affixed, addressed as follows:

The R2CTPO shall maintain accurate public records of all services rendered in the performance of the agreement and shall provide access to such records in accordance with Florida Statutes, Section 119.07(1) (a), which states that the record can be inspected and copied by any person desiring to do so, at any reasonable time, under reasonable conditions and under supervision by the custodian of the public records. All records shall be maintained according to the State of Florida, *General Records Schedule GS1-SL for State and Local Government Agencies*, issued by the Department of State, State Library and Archives of Florida, in accordance with the

statutory provisions of Chapters 119 and 257, Florida Statutes. If any audit, litigation, claim, negotiation or other action involving the records has been started before the expiration of the retention period and disposition of the records, the records shall be retained until the completion of the action and resolution of all issues which arise from.

10. **PROVISIONS NOTWITHSTANDING**. Notwithstanding the provisions set forth above, nothing contained herein shall alter, amend or change those terms and conditions set forth in the bylaws of the River to Sea Transportation Planning Organization.

This Data Sharing and Usage Agreement, hereafter referred to as "Agreement," establishes the terms and conditions under which the **CITY OF BUNNELL**, hereafter referred to as **agency**, can acquire and use Flagler County Property Appraiser (FCPA) data that is exempt from Public Records disclosure as defined in <u>FS 119.071</u>.

As of July 1, 2021, the Florida Public Records Exemptions Statute was amended as it relates to the publicly available records maintained by the county property appraiser and tax collector. As a result, exempt (aka confidential) parcels and accounts have been added back to our website and data files. No owner names, mailing addresses, or official records (OR) book and pages of recorded documents related to these parcels/accounts, appear on the Property Appraiser's website or in data files. In addition, the Flagler County Property Appraiser's mapping site has been modified to accommodate the statutory change. See Senate Bill 781 for additional information.

The confidentiality of personal identifying information including names, mailing address and OR Book and Pages owned by individuals that have received exempt/confidential status, hereinafter referred to as "confidential data", will be protected as follows:

- 1. The **agency** will not release "confidential data" that may reveal identifying information of individuals exempted from Public Records disclosure.
- 2. The **agency** will not present the "confidential data" in the results of data analysis (including maps) in any manner that would reveal personal identifying information of individuals exempted from Public Records disclosure.
- 3. The **agency** shall comply with all state laws and regulations governing the confidentiality and exempt status of personal identifying information that is the subject of this Agreement.
- 4. The **agency** shall ensure any employee granted access to "confidential data" is subject to the terms and conditions of this Agreement.
- 5. The **agency** shall ensure any third party granted access to "confidential data" is subject to the terms and conditions of this Agreement. Acceptance of these terms must be provided in writing to the **agency** by the third party before personal identifying information is released.

The term of this Agreement shall commence on June 1, 2023, and shall run until June 30, 2024, the date of signature by the parties notwithstanding. This Agreement shall not automatically renew. A new agreement will be provided annually for the following year.

IN WITNESS THEREOF, both the Flagler County Property Appraiser, through its duly authorized representative, and the **agency**, through its duly authorized representative, have hereunto executed this Data Sharing and Usage Agreement as of the last below written date.

Summary/Highlights:

The applicant is requesting a small-scale amendment to the City of Bunnell Comprehensive Plan to change the Future Land Use Map (FLUM) designation for 5.0 acres of land from the Conservation-1 (CON-1) to the Agriculture and Silviculture (AG&S) Future Land Use designation.

In accordance with local notification requirements, letters providing notice of the meeting date, time and location were mailed out on May 16, 2023 to adjacent property owners within 300 feet of the subject property within the City of Bunnell limits. Signs with information of the public hearing were posted on the subject property on May 16, 2023.

This item was last heard at the June 12, 2023 City Commission Meeting. At this meeting, the City Commission voted to approve the proposed Ordinance. In accordance with Florida Statute, this item was advertised in the June 15, 2023 edition of the Palm Coast Observer.

Background:

The applicant, Stephen Strickland, has recently created the subject property which totals 5.0 acres. The purpose behind this request is so the applicant can construct a single-family residence. The City is currently undergoing Phase 2 of the mass rezoning which will include properties that do not have City of Bunnell zoning but had some portions of the property listed assigned a Future Land Use of Conservation. Phase 3 will involve removing Conservation-1 and Conservation-2 from the

Land Development Code and the Comprehensive Plan. The applicant did not favor the timeline for Phase 3 which his property would have been included in, and has decided to move forward with paying the costs to have the Future Land Use amended ahead of the City's initiative.

The parcel's current FLUM designation is "Conservation-1". This land use designation, under FLU Policy 11.1, consists of all lands deemed environmentally significant to be verified by appropriate jurisdictional field analysis, and regulated by applicable jurisdictional oversight, but not under a conservation easement or other permanent protection. The established residential density is one unit per five acres; however, it is required to be developed on adjacent uplands or Category 2 wetlands.

The proposed FLUM designation is "Agriculture and Silviculture". Under FLU Policy 16, this land use accommodates for a range of agricultural uses while also including low density residential development including modular, mobile, and manufactured homes at a density of one dwelling unit per five acres. This will be consistent with the proposed changes that are to be implemented once Phase 3 of the City mass rezoning is adopted, if this property were to be included.

WHEREAS, the real property which is the subject of this Ordinance is described by Tax Identification Parcel Number: 01-13-30-0000-01010-0020, located in the City of Bunnell; and

WHEREAS, the owner of the property, Stephen Strickland, has requested this change to the future land use; and

WHEREAS, the City of Bunnell's Planning, Zoning and Appeals Board, as the City's local planning agency, held a public hearing on May 2, 2023 to consider amending the Future Land Use Map of the Future Land Use Element of the *City of Bunnell Comprehensive Plan* and recommend approval of the proposed Future Land Use Map amendment to the *Comprehensive Plan* for the subject property as requested by the property owner; and

WHEREAS, Section 163.3187, *Florida Statutes*, relates to the amendment of adopted local government comprehensive plans and sets forth certain requirements relating to small scale amendments and which are related to proposed small-scale development activities and provides, among other things, that such amendments may be approved without regard to statutory limits on the frequency of consideration of amendments to the *City of Bunnell Comprehensive Plan*; and

Section 6. Conflicts.

All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 7. Codification/Instructions to Code Codifier.

It is the intention of the City Commission of the City of Bunnell, Florida, and it is hereby ordained that the provisions of this Ordinance shall become and be made a part of the codified version of the City of Bunnell 2035 Comprehensive Plan and/or the Code of Ordinances of the City of Bunnell, Florida in terms of amending the Future Land use Map of the City.

Section 8. Effective Date.

The small-scale Comprehensive Plan amendment set forth herein shall not become effective, in accordance with Section 163.3187(5)(c), *Florida Statutes*, until 31 days after the enactment of this Ordinance. If challenged within 30 days after enactment, the small-scale amendment set forth in this Ordinance shall not become effective until the State land planning agency or the Administration Commission, respectively, issues a final order determining that the subject small-scale amendment is in compliance with the controlling State law.





The applicant is requesting an amendment to the official zoning map to change the zoning for 5.0 acres of land from Flagler County "AC, Agriculture" to City of Bunnell "AG&S, Agricultural and Silviculture District".

In accordance with local notification requirements, letters providing notice of First Reading were mailed out on May 16, 2023, to adjacent property owners within 300 feet of the subject property within the City of Bunnell limits. Signs providing information of the public hearing were posted on the subject property on May 16, 2023.

This item was last heard at the June 12, 2023 City Commission Meeting. At this meeting, the City Commission voted to approve the proposed Ordinance. In accordance with Florida Statute, this item was advertised in the June 15, 2023 edition of the Palm Coast Observer.

Background:

The applicant, Stephen Strickland, recently created a 5.0 acre parcel that is 0.15 miles east from County Road 304. The applicant plans to develop the subject parcel for a single-family residence.

The property is currently zoned Flagler County "AC, Agriculture". As of now, the City is undergoing Phase 2 of a 3-Phase mass rezoning. Phase 2 will be rezoning properties that were annexed into

the City of Bunnell back in 2006-2007 to City zoning from Flagler County zoning. when these properties were incorporated, they were given a City of Bunnell Future Land Use but were never assigned a zoning classification, therefore retaining the obsolete County zoning. Phase 3 will be ridding Conservation-1 and Conservation-2 land uses in the Comprehensive Plan and amending the FLUM of the properties affected which would have included the parent parcel of this subject property. The applicant does not favor the timeline that was given for Phase 3 to be adopted and has requested this change ahead of what the estimated timeline would be for the changes to be enacted by the mass rezoning project.

The proposed zoning classification is City of Bunnell "AG&S, Agricultural and Silviculture District". This zoning classification allows for a residential density of one (1) dwelling unit per five acres. This will be consistent with the proposed Future Land Use and with what is proposed for Phase 2 & 3 of the mass rezoning. The current County zoning is obsolete and will not allow for any development to occur on the subject property. Amending the zoning to City zoning will relieve this restraint and will allow for the applicant's plans to move forward.

WHEREAS, Stephen Strickland, the owner of certain real property, which land totals 5.0 acres in size and is assigned Tax Parcel Identification Number 01-13-30-0000-01010-0020 by the Property Appraiser of Flagler County; and





Summary/Highlights:

This is a request by Clinton and Kathryn Palmer for the voluntary contraction of the City's Boundary for 42.6+/- acres of property located north of the intersection between State Highway 11 and County Road 304.

The two pieces of property that are included in this request can be identified by the following Parcel ID numbers assigned by the Flagler County Property Appraiser's Office:

- 19-13-30-1650-01060-0020 (8775 State Hwy 11)
- 19-13-30-1650-01060-0050

In accordance with Florida Statute, the written notice to Flagler County Board of Commissioners regarding this voluntary contraction was sent on May 24, 2023.

Background:

The applicants, Clinton and Kathryn Palmer, own both parcels of land located within the City of Bunnell. The Palmers have petitioned the City of Bunnell to de-annex these properties from its corporate limits under the reason that City services are not provided to these two parcels. Under Chapter 171.052, Florida Statutes, only land that does not meet the criteria for annexation in F.S. 171.043 can be excluded from municipal boundaries. A feasibility study is required to be performed and has been submitted by the applicant. The study found that this property is eligible for de-annexation based on the criteria for municipal contraction set forth in Chapter 171.052 of the Florida Statutes; However, contrary to the reason of the applicant's request, the only City services not provided to these parcels are water and sewer. Solid Waste services are available to all

properties within the City of Bunnell limits, including the ones in this request. Community Development services, such as permitting, plan review, and inspections, are available to these parcels upon application submittals to the Department of Community Development.

Staff Recommendation:

ORDINANCE 2023-13

AN ORDINANCE OF THE CITY OF BUNNELL, FLORIDA FOR THE VOLUNTARY CONTRACTION (DEANNEXATION) OF THE CITY BOUNDARY BY DEANNEXING 42.6+/- ACRES MORE OR LESS OF REAL PROPERTY, GENERALLY LOCATED NORTH OF INTERSECTION COUNTY ROAD 304 AND STATE HIGHWAY 11, MORE PARTICULARLY AND LEGALLY DESCRIBED ON EXHIBIT A, ATTACHED HERETO AND FULLY INCORPORATED HEREIN BY THIS REFERENCE; PROVIDING FOR THE AMENDMENT OF CITY BOUNDARIES TO CONTRACT THE SUBJECT PROPERTIES FROM THE CITY BOUNDARIES; PROVIDING FOR REPEAL OF PRIOR INCONSISTENT ORDINANCES AND RESOLUTIONS, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, Chapter 171, *Florida Statutes*, provides the exclusive method of municipal annexation or contraction in order to ensure sound urban development and efficient provision of urban services; and

WHEREAS, Clinton and Kathryn Palmer own two parcels which are the subject of this ordinance, identified by Flagler County Tax Parcel ID Numbers: 19-13-30-1650-01060-0020 and 19-13-30-1650-01060-0050 collectively totaling approximately 42.6+/- acres, such property described in Exhibit A and illustrated in Exhibit B, and incorporated herein by reference is contiguous to the corporate limits of the City of Bunnell; and

WHEREAS, the owners have requested that the City deannex these parcels; and

WHEREAS, these parcels fail to meet all of the criteria of Chapter 171.043, F.S., specifying the character of an area that may be annexed upon the proposal of a municipality; and

WHEREAS, this parcel has not been developed for urban purposes; and

WHEREAS, the contraction of this parcel will not result in a portion of the City becoming noncontiguous with the rest of the municipality; and

WHEREAS, upon adoption of this Ordinance, the municipal boundary lines of the City of Bunnell shall be redefined to exclude the subject real properties.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF BUNNELL, FLORIDA:

Section 1. Recitals.

The foregoing recitals are true and correct and are fully incorporated herein by this reference.

Section 2. Contraction of Subject Properties.

The Subject Properties as illustrated in Exhibit "B" shall be, and are hereby deannexed from the City of Bunnell, Florida. These properties are described in Exhibit "A" and illustrated in Exhibit "B". The Subject Properties shall be excluded from the existing boundaries of the City of Bunnell, Florida, from the effective date of this Ordinance.

Section 3. City Boundaries Redefined.

- (a) within seven (7) days of the adoption of this Ordinance, the City Clerk shall file a copy of said Ordinance with the Clerk of the Court (Land Records/Recording), with the Chief Administrative Officer of Flagler County (the County Administrator), with the Florida Department of State, and with such other agencies and entities as may be required by law or otherwise desirable.
- (b) The City Manager, or designees within City management staff, shall ensure that the properties contracted/de-annexed by this Ordinance are removed from the *City of Bunnell Comprehensive Plan*, the Official Zoning Map of the City of Bunnell and the map of the City Limits of the City of Bunnell in an expeditious manner.
- (c) The City Manager, or designees, are hereby authorized and directed to legally describe and map the revised City Limits of the City of Bunnell and to take any and all appropriate actions or propose actions to the City Commission as may be authorized in accordance with controlling law.

Section 4. Repeal of Prior Inconsistent Ordinances and Resolutions.

All ordinances and resolutions or parts of ordinances and resolutions in conflict herewith are hereby repealed to the extent of the conflict.

Section 5. Severability.

If any section, subsection, sentence, clause, phrase, word or provision of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, whether for substantive, procedural, or any other reason, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions of this Oridnance.



Background:

The subject property is identified as Parcel ID numbers: 19-13-30-1650-01060-0020 & 19-13-30-1650-01060-0050. Parcel 19-13-30-1650-01060-0020 is owned by Clinton & Kathryn Palmer. Parcel 19-13-30-1650-01060-0050 is owned by Clinton Palmer. Parcel 19-13-30-1650-01060-0020 is 31.6± acres in size. It is addressed as 8775 State Highway 11. It contains a recently constructed single-family residence, horse barn, and equipment storage building. Three people reside on the property. Parcel 19-13-30-1650-01060-0050 is 10.98± acres in size and is an adjacent parcel of land that has not been assigned a street address. There are no physical improvements on Parcel 19-13-30-1650-01060-0050.

The lands surrounding the subject property is a rural area. It is a sparsely developed area with a very low population density below 100 people per square mile. North and west of the subject property is Middle Haw Creek. Middle Haw Creek is a large blackwater stream that is surrounded by a dense natural floodplain forest. South and west of the subject property are lands used for agricultural purposes and rural residential development. See the attached aerial location map which shows the subject property and its surrounding rural area.

Clinton and Kathryn Palmer have filed a petition to de-annex the Subject Property from the City of Bunnell and have commissioned this analysis at your request.

This report analyzes the feasibility of contracting the subject property from the municipal boundaries of the City of Bunnell consistent with *Chapter 171.052*, *F.S. Criteria for contraction of municipal boundaries*. Chapter 171.052, F.S. states that (1) "Only those areas which do not meet the criteria for annexation in s. 171.043 may be proposed for exclusion by municipal governing bodies...". Under Chapter 171.043, F.S., areas may be annexed only if lands are: (1) contiguous to the municipality's boundaries per Chapter 171.043 (1), F.S., and (2) meets the requirements of either Chapter 171.043(2) or Chapter 171.043 (3).

Analysis:

Criteria: Chapter 171.043(1) requires that the total area to be annexed must be contiguous to the municipality's boundaries at the time the annexation proceeding is begun and reasonably compact. No part of the area to be annexed shall be included within the boundary of another incorporated municipality.

Findings: The Subject Property meets this criterion for areas to be annexed. It is contiguous to other lands that are incorporated into the City of Bunnell so that a substantial portion of the subject property's boundary is coterminous with the boundary of the City.

Criteria: Chapter 171.043(2) requires that the area to be annexed must be developed for urban purposes which is defined as a developed area that meets any of the following:

- (a) A total resident population equal to at least two persons for each acre of land; or
- (b) A total resident population that equals at least one person for each acre of land and is subdivided into lots and tracts so that at least 60 percent of total number of lots and tracts are 1 acre or less in size; or
- (c) Is developed with at least 60 percent of total number of lots and tracts in area at the time of annexation that are used for urban purposes and is subdivided into lots and tracts so that at least 60 percent of the total acreage, not counting the acreage used at the time of annexation for nonresidential urban purposes, consists of lots and tracts 5 acres or less in size.

Findings: The proposed contraction area fails to meet the three criteria in Chapter 171.043(2) since the Subject Property has a population density of less than 1 person per acre, is not divided into parcels of less than 1 acres is size and each parcel is substantially larger than 5 acres. No part of the subject property is used for urban purposes.

Criteria: Chapter 171.043(3) states that in addition to being developed for urban purpose, an area may be included in the land to be annexed any additional area which does not meet the requirements of subsection (2), if the area either:

- (a) lies between the municipal boundary and an area developed for urban purposes, so that the area developed for urban purposes is either not adjacent to the municipal boundary or cannot be served by the municipality without extending services or water or sewer lines through such sparsely developed area; or
- (b) is adjacent, on at least 60 percent of its external boundary, to any combination of the municipal boundary and the boundary of an area or areas developed for urban purposes as defined in subsection (2).

Findings: The proposed contraction area fails to meet Criteria 171.043(3) since the Subject Property does not lie between Bunnell's municipal boundary and an area developed for urban purposes nor is any

part of the subject property adjacent to lands used for urban purposes as defined in Chapter 171.043(2), F.S.


Criteria: Chapter 171.052 states that if area proposed to be excluded does not meet the criteria of s. 171.043, but such exclusion would result in a portion of the municipality becoming noncontiguous with the rest of the municipality, then such exclusion shall not be allowed.

Findings: Contraction of the Subject Property would not separate the City of Bunnell from any of its remaining corporate limits. See the attached map which depicts the location of the property in relation to Bunnell's municipal boundary. The proposed contraction does not create any noncontiguous areas within the city.

Conclusion:

The proposed contraction of the Subject Property meets the criteria established by Chapter 171.052 F.S. for contraction of municipal boundaries since the subject property fails to meet the criteria for annexation in s. 171.043. The Subject Property fails to meet criteria outlined in Chapter 171.043(2) or Chapter 171.043 (3). Finally, contraction of the Subject Property would not result in the creation of noncontiguous areas within the boundaries of the City.

Excluding the subject property from the corporate limits of the City of Bunnell is feasible based on the findings above. The proposed contraction will have no impact on the City's provision of services to or connection with any urban area as defined by Florida Statutes.





FACILITY ALERTS

- Coquina City Hall located at 200 S. Church Street is <u>not</u> currently available to rent.
 - The remediation of the hall was completed in August/September. The City is working with the design consultant for the construction plans to design the restoration of the building.
 - Design is complete and approved by both the State and Federal governments. Because of the historic designation on this building, any design plans need to be approved by the State and Division of Historical Resources.
 - The RFP for construction was released in March and the City is working on a contract with a construction company.
- Municipal Park is at its new location: 1307 E. Howe Street (former Clegg Property)

Garage Sale Permits:

The City is accepting requests for Garage Sale Permits. Residents need to make their request to the Utility Billing Department. Per the City Code of Ordinance, there is a limit on the total number of garage sale permits that can be issued to a property/address point in a calendar year. Administrative Services

Information Technology

A storm rolled through, shortly after getting the camera system at the Public Works complex back up and running, and took down a wireless bridge. Need to order a replacement radio.

The County is testing an upgrade to the Computer Aided Dispatch (CAD) system. They requested installing the new software on a desktop, and a couple of the laptops for testing purposes, and to attempt to identify problems. Installed it on the training computer, and 3 of the MDTs.

Community Development added a Planner to staff. Ordered equipment, ran some additional network cabling, and assisted in remodeling their offices to allow room for the new planner.

Upgraded a database utilized by Fleet, migrated them to the cloud offering by the same publisher. This allows them to open the database from a tablet within the bays.

The PD hired 3 new Officers. Ordered new phones, WiFi, and setup accounts and equipment for the new officers.

The lease agreement for most of our fleet of copiers comes to term in the next fiscal year. Met with the copier company to discuss refreshing our hardware, and if we need to include funding in the upcoming budget.

Assisted the Clerk's Office with a number of meetings, minutes, etc.

Provided the Annual Budget Input Training. We haven't done this in person for a couple years. Updated the slide deck, and provided it in person and via Teams.

Received notification from the Florida Department of Management Services of a Cyberse-curity Grant award. The state is to provide licensing for Cybersecurity capabilities.

Assisted the SO Real Time Crimes Center with access to, and exporting video from the Avigilon Camera System.





City Clerk Office

The City Clerk Office published and noticed all agendas for the City's Public meetings held in May. Public Meetings are City Commission meetings, workshops and Executive Strategy Sessions, and any volunteer Board meetings such as the Planning, Zoning and Appeals Board and Code Enforcement Board.

The Clerk's Office also worked on the following issues throughout the month:

- Working with contractor for the design for reconstruction of Coquina City Hall and on-going contact with Department of State for the Historical Resources Grant for the restoration of Coquina City Hall (agreements executed in October); design plans are 100% complete. Because this is a National Historic Building, both the State and Federal Historic Preservation offices have to approve any changes to the building. The plans are approved.
- The RFP for Coquina Reconstruction Phase 1 was released on March 27, 2023 and Bid Opening occurred on May 9, 2023. The Selection Committee met and the City is working to negotiate a contract with a construction firm at this time.

Business Tax Receipts (BTRs)

The City is preparing for the FY 23/24 renewal notices to be sent out. All notices for FY 23/24 will be mailed out to the address of record for each registered business before July 1, 2023. If you have changed your mailing address, you need to update it now.

Businesses should pay their BTR Renewal fees by September 30, 2023 to avoid paying penalties and/or code enforcement action. Florida Statute and the City's Code of Ordinance require penalties be added to a BTR if not paid by **September 30th**. The required penalties are as follows: 10% October 1st; 15% November 1st; 20% December 1st; and 25% January 1st.

In the month of May, 21 businesses either renewed their BTR or received their initial BTR. The City collected \$1,551.53 in BTR and Fire Inspection fees for May 2023.

Grant Projects: Expense Grant Amt

Community Development Block Grant (CDBG) - Hymon: \$15,250 \$700,000 This project would install underground storm conveyance pipes and catch basins along both sides of Hymon Circle allowing rainwater to properly drain instead of consistently flooding the residents' front yards. Also, included in this project would be the clearing and widening of the main drainage canal running from E. Short St. and Hymon Circle south along US1 to our MS4 outfall. Cart Placement Regulations and Guidelines

- ⇒ Face lid opening of cart toward the street (handles & wheels facing house)
- ⇒ Place front of cart within 3 feet of street edge
- ⇒ Allow 2 to 3 feet of clearance on each side of all carts and ANY obstruction
- ⇒ Do NOT fill carts with construction debris, dirt or yard waste
- ⇒ It is recommended to place carts out the night before. The driver is not able to turn around if your cart is not out when the truck has passed your location
- ⇒ Do not place carts near parked cars, fences, mailboxes, trees, other carts, or any other obstruction that could interfere with the truck picking up your cart.

Failing to follow the guidelines may result in service interruption (i.e. the City won't be able to collect your solid waste that day)
